Names and Romanizations

The names of authors who have pursued careers primarily in East Asian academic institutions are given in the East Asian order, surnames followed by personal names, unless they have expressed another preference. The names of other authors are given in the Western form, surnames last. To reduce confusion in identifying references cited at the end of each paper, the surnames of all authors are printed there in small capitals. The surnames of the contributors to this volume also appear in small capitals in the table of contents, in the list of contributors, and on the first pages of their respective essays.

A list of romanizations and their corresponding vernacular scripts follows each of the chapters. The letters K, C, J, O, and V, written in parentheses after each word, indicate Korean, Chinese, Japanese, Okinawan, and Vietnamese, respectively. Korean words have been romanized according to the McCune-Reischauer system. Chinese words are romanized according to pinyin, Japanese and Okinawan words according to Hepburn, and Vietnamese words according to the Quốc ngữ system. In romanizing authors' names, however, we have tried to determine and follow the author's own preference.
