ABOUT THE CONTRIBUTORS

- UMESAO Tadao is the Director of the National Museum of Ethnology. Dr. Umesao was born in 1920, graduated from Kyoto Imperial University and holds a Doctor of Science degree. He specializes in comparative civilization studies, and has been engaged in ethnological investigations in Mongolia, Afghanistan, Africa, Europe and other regions since 1944. His works include 『東南アジア紀行』, 『サバンナの記録』, 『文明の生態史観』, 『民族学博物館』, and 『地球時代の日本人』.
- FUJII Joji is an Associate Professor at the Research Institute for Humanistic Studies, Kyoto University, specializing in modern Japanese history. He was born in 1947. His undergraduate degree is from the Faculty of Literature of Kyoto University. He was later appointed Assistant Researcher of Kyoto University (Faculty of Literature, Japanese History Course) and Associate Professor of Kobe University (Faculty of Literature). He assumed his present post in 1983. His publications include 「幕藩制初期の藩財政」, 「幕藩制領主論」, 「譜代藩制成立期の様相」, and 「幕藩官僚制論」.
- D. Eleanor WESTNEY is an Associate Professor at Massachusetts Institute of Technology specializing in comparative studies in organizational activities and international management. She was born in Canada in 1947, graduated from University of Toronto, and was appointed Assistant Professor of Yale University before occupying her present position. Her publications include "Western Organizational Models in Meiji Japan: The Case of the Keishi-cho and the Paris Prefecture of Police," and *Imitation and Innovation: The Emulation of Western Organizational Forms in Meiji Japan*.
- Harumi BEFU is a Professor of Anthropology at Stanford University specializing in Japanese culture. He was born in the U.S.A. in 1930 and lived in Japan in his childhood. He graduated from the University of Wisconsin and obtained a doctorate in anthropology. His works include *Japan: An Anthropological Introduction* (translated into Japanese by Yasuyuki Kurita et al.) and *The Challenge of Japan's Internationalization: Organization and Culture* (co-ed.).
- Kurt W. RADTKE is an Associate Professor at The Institute of Japanese Studies, Leiden University, specializing in the relationship between Japan and China and comparative study of Japanese and Chinese politics and culture. He was born in Tübingen, West Germany, in 1945, and graduated from Leiden University. He was appointed Lecturer at Waikato University in New Zealand before occupying his present position. His publication include "Global Strategy and Northeast Asia", "Problems in the Comparative Study of Japanese, Chinese and Western Literature" and "China, Japan and Multipolarity".

- HAMASHITA Takeshi** is an Associate Professor at The Institute of Oriental Culture, The University of Tokyo, specializing in the history of modern Chinese economy. He was born in Shizuoka in 1943, and graduated from The University of Tokyo (Faculty of Literature). His publication include 「近代アジア市場とイギリス」 and “A History of the Japanese Silver Yen and the Hongkong and Shanghai Banking Corporation, 1871-1913”.
- KIM Taik-kyoo** is a Professor at Yeongnam University, specializing in cultural anthropology and studies in Korean folklore. He was born in 1929, and graduated from the graduate school of Yeongnam University. He came to Japan as guest professor of the National Museum of Ethnology in 1978 and as guest professor of The Institute of Oriental Culture of The University of Tokyo in 1981. His works and papers related to Japanese culture include 『同族部落の生活構造史』, 『郷歌の生成背景研究』, 『韓国民族文芸論』 and 『韓国農耕歳時の研究』.
- MATSUBARA Masatake** is an Associate Professor at the National Museum of Ethnology specializing in social anthropology. He was born in 1942 in Hiroshima Prefecture, and graduated from Kyoto University (Faculty of Literature). He was appointed Assistant Researcher and later Lecturer, at The Research Institute for Humanistic Studies at Kyoto University before occupying his present post. Since 1967 he has been engaged in ethnological studies on Turkey and Central Asia. His works and papers include 『遊牧の世界』, 『青蔵紀行』, 『トルコの人びと』 and “Turkish Kinship Terminology: Its Historical Changes and Dialectal Distribution”.
- SUZUKI Tadashi** is an Associate Professor at The Institute of Oriental Culture, The University of Tokyo, specializing in the history of the Ottoman Empire and comparative politics. He was born in 1947, graduated from The University of Tokyo (Faculty of Law), and obtained a doctorate in law. His papers include 「オスマン・トルコ社会思想の一側面」, 「オスマン・トルコ支配エリートの研究」 『行政・軍事制度—オスマン・トルコの場合』 and 『官僚の世界』.
- HATA Nobuyuki** is an Associate Professor at the National Museum of Ethnology. He was born in Osaka in 1941, and graduated from Kyoto University (Faculty of Literature). He was appointed Lecturer at Tenri University before occupying his present post. Since 1963 he has been engaged in ethnological studies on eastern and western Africa. His works and papers include 『サバンナの農民』 and 「国家と文明の組織論」.
- YANO Toru** is a Professor at The Center for Southeast Asian Studies of Kyoto University specializing in the history of diplomacy, and studies international relationships and Southeastern Asia. He was born in Kumamoto Prefecture in 1936, and graduated from Kyoto University (Faculty of Law). He was appointed Associate Professor of Hiroshima University and Associate Professor of George Washington University before occupying his present post. His works include 『「南進」の系譜』, 『日本の南洋史』.
