**Kyonosuke Hirai** is Professor of Anthropology at the National Museum of Ethnology, Japan, and is also teaching Social Anthropology at SOKENDAI (The Graduate University for Advanced Studies). He received his Ph.D. from Department of Anthropology, London School of Economics and Political Science. **Mun Young Cho** is Associate Professor of the Department of Cultural Anthropology at Yonsei University, South Korea. She received her B. **Sumi Cho** is Assistant Professor at Bangmok College of General Education, Myongji University, South Korea.
